Please read carefully before signing

1. I acknowledge that shooting activities have inherent danger when firearms are handled inappropriately. While at the GGC I will follow the Safety Doctrine and heed all commands from the designated range officer.
2. I represent that I am under no type of restraining order which prevents my possession and/or use of firearms. I am able to pass the CBI background check and legally free to purchase and own firearms in the state of Colorado.
3. I agree to assume full responsibility of any and all risks, injuries and damages, known and unknown, of whatsoever kind and nature, which I might incur as a result of participating in shooting events at GGC.
4. I assume responsibility for the actions of any and all guests I bring to the GGC range.
5. In consideration of being permitted to participate in shooting events at the GGC, I knowingly, voluntarily and expressly waive any and all claims I, or my Estate, my heirs, or any person claiming under me completely and without reservation that I may have against GGC, its officers, employees, or representatives from any and all kinds of injuries or damages that I may sustain as a result of participating in shooting range activities.
6. I consent to receive medical treatment, which may be deemed advisable in the event of injury, accident and/or illness during the activities at the shooting range.
7. This release shall remain in full force and effect so long as I participate in activities at the GGC.
